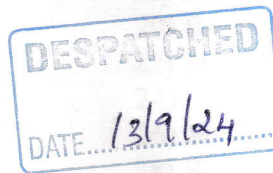
### Terms and Conditions

4. Intending tenderers may submit the quotation on their own letter heads.
5. The parties are requested to specify their GST no. PAN no. and HSN code of the item.
