- Bidders possessing valid Digital Signature Certificate can submit their offers online. The manual submission of the same will not be entertained; online offer through [www.etenders.kerala.gov.in](http://www.etenders.kerala.gov.in) only will be accepted.
- EMD fixed for each item and cost of tender form as per the list has to be paid as per the rules and regulations of the site [www.etenders.kerala.gov.in](http://www.etenders.kerala.gov.in)
- The MSME benefits will be limited only to the MSMEs which are working **within the state of Kerala** (G.O (P) no. 10/2023/SPD dated 11.12.2023)
- Re submission of offer is possible, before last date as permitted in the site.
- Offers are acceptable only up to 5 p m on 06.12.2025
- Opening of e-tender is scheduled at 9.30 a m on 09.12.2025
- Prices should be quoted for delivery of materials at our stores F.O.R KBPS
- Bidders are requested to quote rates in the price schedule (BOQ) only. The basic rate (including freight, loading – unloading charges), GST etc should be quoted separately in the respective columns of BOQ. Please do not quote/mention rates anywhere else in the tender other than BOQ.
- Bidders should submit an affidavit in their letter head stating – “After the receipt of Purchase order, the material will be supplied at KBPS within 10 working days from the date of issuing supply schedule from KBPS general stores, regardless the place of our manufacturing unit/ godown. Enough stock will be kept in advance at the manufacturing unit/ godown accordingly. Deviation from this will attract penalty as decided by KBPS”.**
- The offer should be valid up to 31.12.2026
- If the material is supplied in plastic containers, it is the responsibility of the supplier to take back the container after consumption of the material as per intimation from our Printing/Stores department.
- Parties/contractors who have defaulted in executing purchase order/contract with KBPS or whose purchase order/contract were terminated by KBPS are not eligible to participate in this tender for particular item.
- For finalizing the tender in order to give purchase order to the successful bidder the performance of the bidder during the previous supplies, if any, will also be considered.

In addition to this mother's sister's son/daughter shall also deemed to be a relative. The scanned copy of the declaration (annexure B) in this regard, filled, signed and sealed should be submitted online.
19. The scanned copy of the agreement in Rs. 200/- Kerala stamp paper filled, signed and sealed in every page should be submitted online.
20. The declaration as per annexure B, agreement in Rs. 200/- Kerala Stamp paper and tender document which are incomplete and without sign and seal in every page will be treated as per rules and regulations in the Stores Purchase Manual of the Government of Kerala.
21. All the rights to accept or reject whole or part of the tender without assigning any reason thereof is reserved by KBPS. The decision of KBPS will be final and binding on the tenderer. The Courts at Ernakulam alone shall have jurisdiction over the subject matter of the contract.
