

### Terms and Conditions

1. E-Tenders are invited for the purchase of **Ambulance** at our stores at Kakkanad, Ernakulam, Kerala. Detailed specification required for the new ambulance is given as Annexure C . Intending parties may submit the offers [www.etenders.kerala.gov.in](http://www.etenders.kerala.gov.in) only will be accepted.
2. **Payment will be made only after the satisfactory receipt of the Ambulance in good condition.**
3. The parties are requested to specify their GST no., PAN no. and HSN code of the item.
4. The offer should be valid for 6 months.
5. **The party should quote the rate for new Ambulance**
6. The rates quoted should show the Ex-showroom price at Ernakulam, GST applicable, Insurance Charges (for 1 year) and Vehicle Registration & Lifetime Tax Charges separately. If any of the above or other charges are applicable or to be born by KBPS that should be mentioned clearly in the BOQ.
7. Make/brand and Warranty details of the Ambulance specified by the party in the letter head should be attached
8. Original Equipment manufacturer (OEM) certificate or authorized dealership/distributorship certificate as applicable should be attached
9. Detailed technical specifications highlighting the features should be attached.
10. Clause by clause compliance of specifications and other details as mentioned in the e tender notice should be attached as per the format given in Annexure D
11. All manuals/catalogue related to operation, maintenance and spare parts must be provided with the ambulance in hardcopy.
12. Parties/contractors who have defaulted in executing purchase order/contract with KBPS or whose purchase order/contract were terminated by KBPS are not eligible to participate in this tender for particular item.
13. For finalizing the tender in order to give purchase order to the successful party the performance of the party during the previous supplies, if any, will also be considered
14. Last date for receipt of E-Tenders is at 5 PM on 07.03.2025 Late offers will not be accepted. The E-Tenders will be opened at 11.00 AM on 13.03.2025 in the presence of such of the tenderers or their authorised representatives who may be present at that time.

15. The near relatives of employees of KBPS are not eligible to participate in the tender. The relationship for the purpose will be as specified in Annexure 21 of Stores Purchase Manual of Kerala (extract given as Annexure A). In addition to this mother's sister's son/daughter shall also deemed to be a relative. The scanned copy of the declaration (annexure B) in this regard, filled, signed and sealed should be submitted along with the quotation.
16. All the rights to accept or reject whole or part of the tender without assigning any reason thereof is reserved by the Society. The decision of the Society will be final and binding on the tenderer.
