### Re - e – Tender notice

e-tenders are invited through [www.etenders.kerala.gov.in](http://www.etenders.kerala.gov.in) for **hiring** Fully automatic programmable single knife cutting machines (detailed specification attached as annexure A) - 2 nos. **(installing the machines of required specification inside KBPS premises)**

#### Terms and Conditions

1. All tenders/bid shall be accepted only through online mode (<https://etenders.kerala.gov.in>) and no manual submission of the same shall be allowed.
2. EMD for Rs. 18,000/- should be remitted through online, as per the terms and conditions of the e-tender site.
3. Re - submission of offer is possible, before the last date as permitted in the site.

6. Monthly rental charges (per machine), including cost of cutting knives, cutting stick, spares and other consumables required during the contract period should be quoted. The initial investment towards the transportation, unloading, installation and all other activities at our site should be borne by the party.
7. The offer should be valid up to eighteen (18) months from the date of opening of the tender.
8. The contract will be initially for a period of 1 (one) year from the date of signing but Management reserves the right to extend the contract further at the same price quoted in this e- tender.
9. Parties/contractors who have defaulted in executing any purchase order/contract with KBPS or whose purchase order/contract were terminated by KBPS are not eligible to participate in this tender.
10. The near relatives of employees of KBPS are not eligible to participate in the tender. The relationship for the purpose will be as specified in Stores Purchase Manual of Kerala (extract given as Annexure B). In addition to this mother's sister's son/daughter shall also be deemed to be a relative. The scanned copy of the declaration (annexure C) in this regard, duly filled, signed and sealed should be submitted online.
11. The scanned copy of the agreement in Rs. 200/- Kerala stamp paper duly filled, signed and sealed in every page should be submitted online.
12. Bidders are requested to quote the rates in the price schedule (BOQ) only. The basic rate, GST, taxes/levies, etc should be quoted separately in the respective columns of BOQ. Please do not quote/mention rates anywhere else in the tender other than BOQ.
13. Tenders/bids received online without duly filled, signed and sealed preliminary agreement, Annexure C etc. will not be considered and shall be summarily rejected.

14. All the rights to accept or reject whole or part of the tender without assigning any reason thereof is reserved by the Society. The decision of the Society will be final and binding on the tenderer.
15. All the rules and regulations of the Tender/bid shall be in accordance with the Stores Purchase Manual of the Government of Kerala.

## **Annexure A**

### **Specification for the required fully automatic programmable single knife cutting machine -2Nos.**

#### **I. Technical specification:**

- 1) Type : Guillotine type
- 2) Cutting width = 1000 – 1370 mm (should cut in both limits).
- 3) Cutting depth =1320 mm and above
- 4) Clamp opening (Min) = 165mm
- 5) False clamp facility included.
- 6) Smallest cut without false clamp= 27mm(Max)
- 7) Knife stoke per Min = 20 (minimum).
- 8) Both table and side table should have air cushioning facility. Required air blower should be included with the machinery.
- 9) Hand protection Electronic light safety bar and two hand cut start in built
- 10) Hydraulic power pack included.
- 11) Maximum Clamp pressure : 40KN
- 12) Preferably Electromagnetic clutch.
- 13) Motorized back gauge with ball screw accuracy within  $\pm 5$ mm maximum.
- 14) Back gauge advance speed = 15 cm/sec minimum.
- 15) Display type : TFT color LED/LCD touch panel
- 16) External communication: USB port.
- 17) Memory Capacity: To store min of 100 jobs of 50 pages each.
- 18) Input least count value: 10  $\mu$ m.

#### **II. Other terms and Conditions**

- 1) The machines should be installed with all related and safety attachments.
- 2) Space, electricity, manpower (to operate the machines) will be provided by KBPS.
- 3) Maintenance of the machines should be done by the party.
- 4) The party should keep enough stock of cutting knives, cutting stick, spares and other consumables required during the contract period.
- 5) Knife grinding will be done by KBPS if required.
- 6) Machine must support site power supply as per Indian power supply standards
- 7) All software and accessories like frame work required to mount the system, compressors, UPS, computers etc must be provided along with the systems.
- 8) Work order confirmation will be given only after satisfactory performance in continuous production.
- 9) Payment will be made on monthly basis
- 10) The system should be delivered, installed and commissioned within 15 days from the date of work order.
- 11) The party should submit duly filled specification compliance sheet (available in e-tender site) regarding the technical specification of the offered cutting machine for technical evaluation
- 12) The machine unloading, installation and all other activities at our site must be done by the party.
