6. The successful party should make all the arrangements for unloading of required materials and repairing the machine at the allotted space at KBPS at their own cost.
7. Parties/contractors who have defaulted in executing any purchase order/contract with KBPS or whose purchase order/contract were terminated by KBPS are not eligible to participate in this tender.
8. **Payment will be made only after the satisfactory completion of the repair work of machine in good condition and to the satisfaction of KBPS.**

9. The parties are requested to specify their GST no., PAN and HSN code of the work.
10. The scanned copy of the brochures/specification of the quoted item (in English) should be submitted online and subsequently the original in a separate cover should reach the office of the undersigned on or before the opening time of the tender.
11. The near relatives of employees of KBPS are not eligible to participate in the tender. The relationship for the purpose will be as specified in Annexure 21 of Stores Purchase Manual of Kerala (extract given as Annexure B). In addition to this mother's sister's son/daughter shall also be deemed to be a relative. The scanned copy of the declaration (annexure C) in this regard, duly filled and signed should be submitted online.
12. The scanned copy of the agreement in Rs. 200/- Kerala stamp paper duly filled and signed shall be submitted online and subsequently the original in a separate cover should reach the office of the undersigned on or before the opening time of the tender
13. The scanned copy of the Tender document duly filled, signed and sealed in every page should be submitted online. and subsequently the original in a separate cover should reach the office of the undersigned on or before the opening time of the tender
14. The copy of all the documents submitted online, should reach the office of the undersigned on or before the opening time of the tender.
15. Price should be quoted in Indian Rupee only.
16. The final payment to the successful tenderer, if awarded with the repair work, will only be made according to the actual requirement of spares and labour charges, based on certification of our Technical team and the unit cost submitted as per clause 5.
17. Advance payment requests will be considered only as per the rules and regulations in the Stores Purchase Manual of Kerala State.
18. The repair work should be carried out within the premises of KBPS where the machine is installed.
19. Tenders/bids received through online without duly filled, signed and sealed preliminary agreement, tender document; Annexure C will be treated in accordance with the Stores Purchase Manual of the Government of Kerala and its amendments from time to time.
20. All the rights to accept or reject whole or part of the offer without assigning any reason thereof is reserved by KBPS. The decision of KBPS will be final and binding on the tenderer. The Courts at Ernakulam alone shall have jurisdiction over the subject matter of the contract.
21. All rules and regulations of the Tender/bid shall be in accordance with the Stores Purchase Manual of the Government of Kerala.

Technical specification for the Repair Work of Planeta 2 Sheetfed Offset Printing Machine

Current Machine Status

Machine Model : Planeta Sheetfed
Machine Age : More than 40 years
Current Delivery Unit Condition : Broken

Works to be Executed

1. Delivery Unit Replacement
 - a. Replace existing delivery unit. The existing unit contains two stages of delivery. The upgradation must have only one stage.
 - b. All the parts including Frames, Grippers, Shafts, Chain and Sprocket etc. required must be replaced as per the upgradation.
 - c. Removal of the old parts and installation of upgraded parts must be carried out.
2. Alignment and Balancing
Perform through alignment and balancing of the new delivery unit to ensure proper registration and minimal vibration
3. Trials
Satisfactory trials/production run must be carried out after upgradation.
