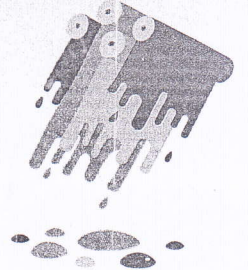

1. The envelopes sealed in four sides and middle by using lacquer seal containing the tender bearing the superscription "Tender for Process Colour Cold Set Inks due on 18.03.2023" and should reach The Managing Director, Kerala Books and Publications Society, Kakkanad P.O., Kochi - 30
2. Intending tenderers may submit the offers on their own papers.
3. EMD for Rs.5000/- should be remitted in the form of Demand Draft of Nationalized bank drawn in favour of Managing Director, Kerala Books and Publications Society, Kakkanad, Kochi-30, along with duly filled, signed and sealed agreement in Rs. 200/- Kerala stamp paper, as per the attached format. **Payment will be made only after the satisfactory receipt of the item in good condition.**
4. The parties are requested to specify their GST no. and HSN code of the item.
5. The offer should be valid for 6 months.
6. Prices should be quoted for delivery of materials at our stores F.O.R KBPS
7. If the material is supplied in plastic containers, it is the responsibility of the supplier to take back the container after consumption of the material as per intimation from our Printing/Stores department.
8. Parties/contractors who have defaulted in executing purchase order/contract with KBPS or whose purchase order/contract were terminated by KBPS are not eligible to participate in this tender for particular item.
9. **Sample of 20 Kg. should be reached at KBPS Stores Department on or before the opening time of the tender.**
10. Last date for receipt of tenders is at 2.00 p m on 18.03.2023. Late offers will not be accepted. The tenders will be opened at 2.30 p m on 18.03.2023 in the presence of such of the tenderers or their authorised representatives who may be present at that time.
11. The near relatives of employees of KBPS are not eligible to participate in the tender. The relationship for the purpose will be as specified in Annexure 21 of Stores Purchase Manual of Kerala (extract given as Annexure A). In addition to this mother's sister's son/daughter shall also deemed to be a relative. **The scanned copy of the declaration (annexure B) in this regard, filled, signed and sealed should be submitted online.**
12. All the rights to accept or reject whole or part of the tender without assigning any reason thereof is reserved by the Society. The decision of the Society will be final and binding on the tenderer.
