

e - tenders are invited through www.etenders.kerala.gov.in for the Supply, Erection, Installation, Testing and Commissioning of **flow line binding machine** - **1no.**, with the technical specification attached as Annexure A, in two bid system.

Terms and Conditions

1. Bidders possessing valid Digital Signature Certificate can submit their offers online. The manual submission of the same will not be entertained; online offer through www.etenders.kerala.gov.in only will be accepted.
2. Resubmission of offer is possible, before the last date as permitted in the web site.

4. An online pre bid meeting will be arranged by KBPS on the aforesaid date. Those who are interested for participating in the meeting should send their details/queries to the e-mail id: kbpspurchase@gmail.com within the time mentioned in the above table.
5. Prices quoted should be for the supply, erection installation, testing and commissioning of the machine at KBPS, Kakkanad, Kochi - 682030
6. Bidders are requested to quote rates in the price schedule (BOQ) only. The basic rate (including all expenses like transportation of the machine till KBPS, unloading and positioning of the machine) till the commissioning of the machine at KBPS, Indian GST, taxes/levies should be quoted separately in the respective columns of BOQ. Please do not quote/mention rates anywhere else in the tender other than BOQ.
7. Three-year comprehensive warranty should be provided
8. The successful party should provide sufficient training to the concerned staff of KBPS.
9. The successful party should make all the arrangements for unloading, positioning and installing the machine at the allotted space at KBPS at their own cost.

10. Parties/contractors who have defaulted in executing any purchase order/contract with KBPS or whose purchase order/contract were terminated by KBPS are not eligible to participate in this tender.
11. Payment will be made only after the satisfactory receipt, installation and commissioning of the machine in good condition and to the satisfaction of KBPS.
12. The tenderer should submit an undertaking in their own letterhead (as per the format attached in tender document) stating that if they are the successful tenderer they are ready to supply the spares having proprietary nature for the installed machine without any advance payment towards the cost of the same. The payment term will be: "Payment will be made only after the receipt of spares in good condition."
13. The parties are requested to specify their GST no., PAN no. and HSN code of the item.
14. The scanned copy of the brochures/specification of the quoted item (in English) should be submitted online and subsequently the original in a separate cover should reach the office of the undersigned on or before the opening time of the tender.
15. The near relatives of employees of KBPS are not eligible to participate in the tender. The relationship for the purpose will be as specified in Annexure 21 of Stores Purchase Manual of Kerala (extract given as Annexure B). In addition to this mother's sister's son/daughter shall also deemed to be a relative. The scanned copy of the declaration (annexure C) in this regard, duly filled and signed should be submitted online.
16. The scanned copy of the agreement in Rs. 200/- Kerala stamp paper duly filled, signed and sealed, in every page should be submitted online and subsequently the original in a separate cover should reach the office of the undersigned on or before the opening time of the tender.
17. The scanned copy of the Tender document duly filled, signed and sealed in every page should be submitted online.
18. Tenders/bids received through online without duly filled, signed and sealed preliminary agreement, tender document; Annexure C will be treated in accordance with the Stores Purchase Manual of the Government of Kerala and its amendments from time to time.
19. All the rights to accept or reject whole or part of the offer without assigning any reason thereof is reserved by KBPS. The decision of KBPS will be final and binding on the tenderer. The Courts at Ernakulam alone shall have jurisdiction over the subject matter of the contract.
20. All rules and regulations of the Tender/bid shall be in accordance with the Stores Purchase Manual of the Government of Kerala.

Annexure A

Specification for the supply, erection, installation, testing and commissioning of flow line machine

Flow line binding machine having the following technical specifications – 01 no.

- A 06 signature feeders +01 cover folder feeder
- b. Mechanical speeds : 8,000 - 10,000 cycles/hour
- c. Size of Untrimmed section
 - Maximum size : 350-370 mm x 290-330 mm
 - Minimum size : 100-130 mm x 114-118 mm
- d. Size of Trimmed section
 - Maximum size : 340-370 mm x 280-301 mm
 - Minimum size : 117-119 mm x 50-70 mm
- e. Cover folder feeder
 - Maximum size : 362 - 367 mm x 607-612 mm
 - Minimum size : 86-91 mm x 162-167 mm
- f. No. of stitching heads : 02 to 04
- g. With standard belt delivery having batch separation facility
- h. With all standard accessories including air compressors/vacuum pump/pressure pumps/UPS etc
- i. Machine should have all the safety trip arrangements ensuring operator safety at all levels
- j. To specify power consumption details
- k. Feeder Details
 - i) Signature feeders : 06 nos. with facility to tilt- back of at least one feeder for manual feeding
 - ii) Hand feeding station : one
 - iii) Must be expandable to add at least two more signature feeders in future
- l. Stitching Heads
 - i) Should have the facility to add and fit at least two more stitching Heads in future when required
- m. Trimmer
 - i) Three – knife trimming with automated size –dependent timing and hand wheels
- n. Automation
 - i) Servo drivers with PLC controls and touch screen
 - ii) Shaft less drive mechanism must be there for individual units like feeder unit, stitching unit, trimmer unit, delivery unit etc.
 - iii) Must have provision to store and recall job settings for standard products (to reduce mal-ready)
 - iv) Remote control to start, jogging and production
 - v) Tool –less settings of feeders and trimmer
- o. Quality control
 - i) Thickness measurement monitor before stitching
 - ii) Staple control
 - iii) Copy control-downstream feeding must be stopped in case of missing sections
 - iv) Reject gate before stitching (to minimize wastage)
- p. Working voltage : 415 volt, 3 phase, 50Hz
