

#### Terms and Conditions

1. The envelopes sealed in four sides and middle by using lacquer seal containing the tender bearing the superscription "Tender for Electrical items due on 18.12.2023" should reach The Managing Director, Kerala Books and Publications Society, Kakkanad P.O., Kochi - 30
2. The rate should be quoted inclusive of all. (tax, forwarding/packing charges and any other charges included in the offer should be specified)
3. **Payment will be made only after the satisfactory receipt of the item in good condition.**
4. Intending tenderers may submit the tender on their own letter heads.
5. The parties are requested to specify their GST no. PAN and HSN code of the item.
6. The offer should be valid for 1 year.
7. **The purchase order may be awarded to separate parties for each item.**
